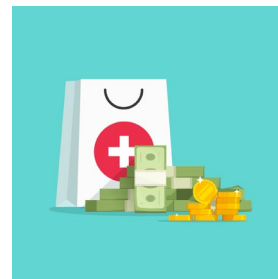
Creating an Emergency Financial Aid Kit

Medication Support for Patients Impacted by Disasters

During an emergency, vital medicines are often damaged or lost. Patients who go without their medicine may eventually end up in the emergency room (ER). The Emergency Prescription Assistance Program (EPAP) tries to help patients avoid the ER. The program allows uninsured patients who have been impacted by a federally-declared disaster to receive up to a 30-day refill of their prescriptions, vaccines, and durable medical equipment at no cost. The EPAP helps ensure patients get the medicines they need when they need them. Learn more about EPAP by clicking on the link below.

Early Hurricane Predictions Call for Fewer Storms in 2019

The 2019 Hurricane Season is two months away, but storm predictors are already saying there will be fewer storms than the 2018 hurricane season. Colorado State University's hurricane research team predicts there will be a total of 13 named storms. According to researchers, the number of storms is close to normal, but the intensity of storms is forecast to be slightly below average.
